

Short-Term Post-Hospitalization Quick Reference Guide

What is Short-Term Post-Hospitalization?

Short-Term Post-Hospitalization Housing provides members who do not have a residence and who have high medical or behavioral health needs with the opportunity to continue their medical/psychiatric/substance use disorder recovery immediately after exiting an inpatient hospital, residential substance use disorder treatment or recovery facility, residential mental health treatment facility, correctional facility, nursing facility, or recuperative care and avoid further utilization of State plan services.

This setting provides Members with ongoing supports necessary for recuperation and recovery, such as gaining (or regaining) the ability to perform Activities of Daily Living (ADLs), receiving necessary medical/psychiatric/substance use disorder care, case management, and beginning to access other housing supports such as Housing Transition Navigation Services.

Who is eligible?

Members that are experiencing homelessness or at risk of homelessness and meet one of the criteria below:

- Have one or more serious chronic conditions:
- Have a Serious Mental Illness;
- Are at risk of institutionalization or overdose or are requiring residential services because of a substance use disorder
- Have a Serious Emotional Disturbance (children and adolescents):
- Are receiving Enhanced Care Management; or
- Are a Transition-Age Youth with significant barriers to
 housing stability, such as one or more convictions, a history
 of foster care, involvement with the juvenile justice or
 criminal justice system, and/or have a serious mental
 illness and/or a child or adolescent with serious emotional
 disturbance and/or who have been victims of trafficking or
 domestic violence.
- Have been discharged from the hospital, substance use or mental health treatment facility, correctional facility, nursing facility, or recuperative care would likely result in hospitalization, rehospitalization, or institutional readmission.

Required Documentation

 Short-Term Post-Hospitalization Housing Information and Referral form, any additional documentation to support request.

Quantity: 1-182 (Days) based on member needs Date of Services: As needed, up to six (6) months
